This email concerns the request for access to information in terms of the Promotion of Access to Information Act 2 of 2000 ("PAIA") delivered to KFC (Pty) Ltd on behalf of Animal Law Reform South Africa on 16 November 2022. In terms of our request and subsequent extension granted, your response to our request was due by no later than **31 January 2023**.
