I refer to our telephone call on 22 November. Thank you for your willingness to engage with us about our request for access to information in terms of PAIA.

During our call you queried whether supplier names could be redacted from the records to be provided to us in terms of PAIA. To clarify, only to the extent that our request entails disclosure of personal information protected by POPIA may it be redacted from the relevant records. Supplier names would not fall within the meaning of personal information in terms of POPIA. Further, whilst we accept that it may be necessary to engage with your suppliers about our request, this does not negate your statutory obligation to respond to us and provide access to records in terms of PAIA.
