Thank you for your email and your willingness to assist.

We have written to you as the Information Officer of the Rhodes Food Group ("RFG") on the basis that RFG produces and/or sells several **brands** that contain eggs as an ingredient. These include "MagPie", "Ma Baker", and "Hinds", among others. RFG is thus a key role player in the egg supply chain and has obligations to advance animal welfare and protect the environment. You will note from our letter that some of the information requested would emerge from RFG's internal policies regarding animal welfare and environmental matters; records concerning RFG's suppliers in the egg supply chain; as well as RFG's own commitments to utilize eggs in its products only from layer hens not housed in cages. We have also asked for details of assets and stocks, and these would relate to details of brands produced/sold that include eggs as an ingredient.

We are happy to provide further clarification, and trust that you will furnish records as requested in our PAIA request in terms of your statutory obligations.
