We would like to thank you for the online meeting you convened with us on 19 January 2023 in your capacity as Company Secretary and General Counsel of Tiger Brands. We would also like to thank, amongst others, your Head of Procurement of Ingredients, Supply Chain Officer, Director of the Culinary Division, and Compliance Officer (collectively the “Tiger Team”) for their attendance and contributions at this meeting.

We appreciate the Tiger Team’s willingness to engage with and seek clarity from us regarding our request for access to information in terms of PAIA.

We also appreciate the Tiger Team informing us that Tiger Brands purchases eggs as a processed ingredient - as opposed to purchasing raw or fresh eggs - often combined with other ingredients. Based on what was conveyed to us during the meeting, we now understand that Tiger Brands does not directly procure products from fresh egg producers. Instead, Tiger Brands procures egg products from suppliers of powdered eggs as an ingredient in your products.

We nevertheless look forward to Tiger Brands providing a formal response to our request for access to information in terms of PAIA. Your response will empower us to uphold the right to have the environment protected (including animal welfare) through enhanced corporate accountability relating to food containing eggs and stakeholders in the egg supply chain. Your response will also inform the ranking of Tiger Brands in the public report we are preparing regarding key stakeholders in the egg supply chain.

As you know, Tiger Brand’s response to our request was, in terms of PAIA, initially due on **23 December 2022**. However, an extension was requested by you, to which Tiger Brands is entitled in terms of PAIA. As PAIA affords a 30-day extension period, your response is now due by **27 January 2023**. However, we are willing to provide a further extension to the **3 February 2023** in order for you to give justice to our request.

We look forward to your response to our request by no later than **3 February 2023**.

We thank you for your cooperation, as the information requested will empower us to advance animal welfare concerns in South Africa in pursuit of the fulfilment of the environmental right.
