Indeed, we received your request in terms of the Promotion of Access to information Act on 16 November 2022. I acknowledged receipt of same on 17 November 2022 as evidenced in your mail further below.

On 18 November however we received a notification that you wished to recall your initial email (see attached)). We naturally assumed that you no longer wished to pursue your initial request. This assumption was reasonable and justified as you failed to subsequently clarify the situation since then (some 3 months later).

In terms of our request, your response to our request was due by no later than **20 December 2022**.

We hereby notify you that your non-response to our request amounts to a refusal in terms of PAIA. As such, Woolworths will be negatively ranked in our public report on the basis that you have been non-responsive to our request.

You are hereby given a final opportunity to respond to our request by no later than **3 March 2023** given that we are currently preparing our public report.

Should you fail to do so, we reserve our rights to exhaust the legal remedies available to us, including but not limited to, approaching the Information Regulator to lodge a complaint in respect of Woolworths, and/or approach the courts.
