Thank you for your acknowledgement of receipt of our PAIA request dated 11 December 2023 to Toplay Egg Co-Operative Limited Ltd.

Regarding your query about our registration as a law firm or practice, kindly take note that ALRSA is a non-profit company and a registered NPO (Number 238-234 NPO). ALRSA is not a law firm or practice.

The information requested in relation to our organisation is, in any event, wholly irrelevant. Under PAIA, NPOs possess the same rights as individuals to access information held by public and private entities. PAIA's scope extends broadly, encompassing any person or organisation seeking information. NPOs, as legal entities, can thus utilise PAIA to request information on behalf of the public or for activities aligned with their mission and advocacy. We have made our PAIA request acting in the public interest and in furtherance of the objects of the organisation to protect the constitutionally enshrined environmental right, amongst others.

We trust this clarification addresses your query satisfactorily and look forward to your client's response to our PAIA request by no later than **29 May 2024**.
