Good day

I trust you are well.

Thank you for your response to our correspondence dated **28 March 2024**. We note your claim that the only Unilever product that contains eggs is the Hellman's brand.

We note from the website link provided previously, that "*All Hellmann's mayonnaise, dressings, and spreads **available in the U.S.**, excluding our Vegan Dressing and Spread (which does not contain eggs), have been made exclusively from cage-free eggs since January 2017*". The website however does not reference which items are sold in South Africa. As such, kindly confirm whether these Hellman's products containing eggs sold in South Africa also are sourced from cage-free egg suppliers.

Furthermore, in as far as our request relates to records that are not in the possession of Unilever, you are required in accordance with s55 of PAIA, to provide an affidavit noting the steps taken to locate the information. We hereby request that the requisite affidavit be provided.

Kindly respond to this correspondence by no later than **5 June 2024** given that we are currently preparing our public report in which we will rate Unilever relative to its transparency and stance on animal welfare and environmental sustainability, among other matters. The rating will be informed by your response to this correspondence, as well as the previous correspondence and records provided.

Good day

I trust you are well.

Thank you for your response to our request dated 13 December 2024 to Unilever South Africa (Pty) Ltd ("Unilever").

We note your assertion that "*Unilever does not source locally in South Africa, nor are they used in our South African production*". Kindly provide an affidavit attesting to this claim as required in terms of s 55 of PAIA. We also appreciate you providing us with information concerning Hellmann's. Please could you provide information in relation to other brands that contain eggs, or are we to assume that Hellmann's is the only brand that has made a cage-free commitment?

Given Unilever's commitment to sustainably sourced ingredients, including cage-free eggs, we hope that Unilever will engage openly and transparently with us.

Despite not sourcing eggs locally in South Africa, the sale of *egg related products* to South African consumers renders Unilever a role player in the egg supply chain in South Africa.

As such, we reiterate our request for access to information in terms of our PAIA request dated 13 December 2023. Unilever cannot claim to “[care about sustainability](#)”, but refuse to provide records to organisations such as ALRSA who seek to advance sustainability in the interests of consumers and the environment.

We hope that Unilever will adjust its approach so as to advance transparency and accountability in relation to the environment, noting the Supreme Court of Appeal’s remark that:

“Corporations operating within our borders, whether local or international, must be left in no doubt that in relation to the environment...there is no room for secrecy and that constitutional values will be enforced.”

We look forward to receiving a fully compliant and thorough response to our request in terms of PAIA forthwith. Should you fail to do so, we reserve our rights to exhaust the legal remedies available to us, including but not limited to, approaching the Information Regulator to lodge a complaint in respect of Unilever, and/or approaching the courts.

In terms of our request, and subsequent extension granted, your response to our request was due by no later than **15 January 2024**.

We hereby notify you that your non-response to our request amounts to a refusal in terms of PAIA. Unilever will be rated accordingly in our forthcoming public report relating to corporate accountability in the egg supply chain.

You are hereby given a final opportunity to respond to our request by no later than **6 February 2024** given that we are currently preparing our public report.

Should you fail to do so, we reserve our rights to exhaust the legal remedies available to us, including but not limited to, approaching the Information Regulator to lodge a complaint in respect of Unilever, and/or approach the courts.
