RE: CORPORATE ACCOUNTABILITY PROJECT - REQUEST FOR ACCESS TO INFORMATION

1. We refer to the Request For Access To Information, dated 21 November 2022, from Animal Law Reform South Africa ("**Requester**") under the Promotion of Access to Information Act, 2000 ("**PAIA**") to Rocomamas Franchise Co. (Pty) Ltd ("**Rocomamas**") ("**the Request**").
2. This letter serves as notice to the Requester of Rocomamas' refusal to provide the requested records to the Requester, as the Request fails to meet the mandatory, stipulated procedural requirements in section 53 of PAIA for the reasons set out below:
 - 2.1. The Requester has used the incorrect form for the Request (see Rocomamas PAIA manual available at [rocomamas-franchise-copaia-manual.pdf](#));
 - 2.2. The Requester has failed to provide an explanation of why the requested record is required for the exercise or protection of that right, and how that information would assist the Requester in exercising or protecting that right; and
 - 2.3. Insofar as the Request is purportedly made by Cheslyn Craig Ceaser on behalf of the Requester, to submit proof of the capacity in which the requester is making the request, to the reasonable satisfaction of the head of Rocomamas.

The Requester has the right to lodge a written complaint on Form 5 published under regulation 10 of the PAIA Regulations, to the Information Regulator against the refusal of the request by Rocomamas within 180 days of this refusal, alleging why Rocomamas' decision to refuse access to the record was not in compliance with PAIA.
5. Alternatively, the Requester may, by way of an application, within 180 days of the date of this letter, apply to a competent court for appropriate relief in terms of section 82 of PAIA.
6. All of Rocomamas' rights remain strictly reserved.
